1. Acknowledgement of Risk

I understand and acknowledge that western event practice and related equine activities involve inherent risks, including but not limited to: injuries from animals, falls, equipment failure, collisions with other participants, and unpredictable behavior of horses or livestock. I voluntarily assume all risks associated with participation in these activities on the premises.

2. Release of Liability

In consideration for being allowed to rent and use the arena at Bacon Farms Ltd. I hereby release, waive, discharge, and hold harmless the arena owner(s), property owners, event organizers, volunteers, and affiliates from any and all liability, claims, demands, or causes of action for personal injury, property damage, or death arising from or related to my participation in any activities at the facility.

3. Indemnification

I agree to indemnify and hold harmless the Arena Owner from any loss, liability, damage, or costs they may incur due to my presence or participation, whether caused by the negligence of the Arena Owner or otherwise, to the fullest extent permitted by Ontario law.

4. Arena Rules and Conduct

I agree to abide by all posted rules and any verbal or written instructions given by arena staff or representatives. I understand that failure to do so may result in immediate termination of rental privileges without refund or recourse.

5. Health and Safety

I confirm that I am physically capable of participating in equine and western event related activities. I acknowledge that I am responsible for using appropriate safety equipment.

All participants under the age of 18 are required to wear a properly fitted, ASTM/SEI-certified riding helmet while mounted at all times. This is a mandatory condition of participation.

6. Minors

If signing on behalf of a minor, I certify that I am the legal parent or guardian of the participant and consent to their participation. I accept full responsibility for the minor and agree to all terms of this waiver on their behalf.

Parents or legal guardians of minors are solely responsible for the supervision of their child(ren) while on the premises. Should a parent or guardian choose not to remain present to supervise, they do so entirely at their own risk. The arena and its staff do not provide supervision or care for minors during arena use or activities.

7. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario, and any legal proceedings arising from this Agreement shall be brought in the courts of Ontario.
